I would like to purchase advertising to be included in the 2008 Quilt Show Program for the West Alabama Quilters Guild (hereafter referred to as WAQG) as well as on the web page maintained by the guild (www.waqq.com). The rules and regulations for advertising in the 2008 Quilt Show Program are listed below.

- *ALL advertisement in the 2008 WAQG Quilt show program is in black & white*
- *Advertisement in the 2008 WAQG Quilt show program cannot be changed after January 2, 2008.*
- *Due to time limitations, all proofing will occur by members of the WAQG.*
- *REFUNDS for advertisement will only be provided if there is a discrepancy between the submitted advertisement and the actual advertisement in the WAQG.*
- *Purchase of a 2008 Quilt show program advertisement automatically includes internet advertisement on the WAQG website.*
- *ALL internet advertisement will be the same size due to space limitation on the WAQG home page.*
- *ALL website advertisement will remain on the WAQG web site until December 31, 2008. At that time, the organization can repurchase the website advertisement at the internet price for one more year (January 1 through December 31).*
- *Internet advertisement will begin within two weeks of the receipt of ad and payment.*
- *WAQG reserves the right to remove any advertisement from their web site. An explanation for the removal will be provided and the organization will have the right to request that their advertisement be reinstated once the reason(s) for the removal has been addressed. One possible reason for removal is that the internet address provided is no longer valid or has been compromised. Removal of advertisement is not limited to this reason only.*
- *NO refunds will be provided if the advertisement is removed from the website.*
- *WAQG reserves the right to refuse advertisement. If this occurs, the check will be returned to the organization.*
